1-2) Definition/ types of i.v.s. (international voluntary service)

International voluntary service is voluntary service done internationally beyond the border of the nations. It was started in France, in 1920 for the first time in the world by SCI (Service Civil International) in a workcamp style where European young people including French and German live and work together for some months to reconstruct the fields destroyed by the World War I.

Today, **over 3,000 projects are organized every year in around 90 countries** with coordination of i.v.s. NGOs in each country, where over 100,000 volunteers and millions of local people work together for the betterment of communities on environments, development, cultures, education, social welfare, etc.

There are different ways of definition in each organization/ network of i.v.s. projects, so the below is one of them, but still based on the work done by NVDA and some of the member NGOs/ partner networks.

* As most of **Very Short Term Workcamps** are done in weekends, many of the NGOs which organize this type of projects call them "**weekend workcamps**" (even for the ones organized on Mon.-Fri.).

* LTV and MTV are usually called together (here as "LMTV" while some organizations call "MLTV").

* Most of i.v.s. NGOs **rarely organize/ exchange individual type of very short term or short term** ones (SSTI, STI) while **many of LMTV projects are individual type** (LMTI).

< Other ways of categories >

By the geographical scale (where the volunteers come from):

International (open to any nationalities)/ Regional (e.g. only for Asian)/ Trilateral (3 countries)/ Bilateral (2 countries)/ National/ Local. The projects that could finally get volunteers of only 2-3 nationalities can be still called as "International" if it was originally open to the all over world. * In the wide definition, Regional/ Trilateral/ Bilateral ones can be also called as "international".

* As most of international workcamps are short term, when we just call "international workcamps", it usually means STW (unless specifically mentioned like "long term (international) workcamps").

By themes: Environmental/ Developmental/ Cultural/ Educational/ Social (or Peace and Human rights) * This category is agreed by the Global Meeting of i.v.s. NGOs for the common statistics while again, there are many ways in each organization and network.

By way of gathering volunteers: Group workcamps (organized for the specific groups such as schools, companies, clubs) while others gather individual applications no matter the number of nationalities. * Some organizations call above mentioned "Bilateral workcamps" as "Group workcamps".

1-3) 10 biggest news of NVDA in 2012-13

2,659 i.v.s. projects were organized and 27,716
 volunteers were exchanged by the member NGOs
 The projects increased 22% from 2010-11 and the total number of volunteers increased 0.3%.



 2) 9th TNW (Training & Networking Workcamp) & <u>8th GA (General Assembly)</u> were organized in India, 2012 Feb. 01-10 with RUCHI (host) and 35 NGOs leaders of 21 NGOs in 13 countries.



3) International workcamps were started in 2 "new countries", in Sri Lanka and Myanmar in 2012. In 2013, GV4GF organized 13 workcamps in Sri Lanka and COM did 8 ones in Myanmar, together with NICE.



4) Global LMTV Meetings were organized in India, 2012 Feb. hosted by FSL and Slovakia, 2013 Mar. with 22 leaders of 14 NGOs in 10 countries (2012) and 21 leaders of 19 NGOs in 17 countries (2013).



5) Asian LTV Summit was organized in Japan, 2013 Nov.12-17 with NICE (host), Japan Foundation (sponsor) and 22 LMTV leaders from 15 NGOs in 13 countries to share know-how and strengthen links.



6) 2nd Asian PR Summit for i.v.s. NGOs was
 organized in Vietnam, 2013 Jan. 17-23 with SJV (host) and 31 PR leaders of 22 NGOs in 16 countries to empower PR skills and strategies.

7) NVDA sent 185 volunteers in 19 group workcamps hosted by 8 members in 7 countries! All volunteers were students from HKIEd (Hong Kong Institute of Education).



8) Asian common actions of World Tanabata Action and Eco Sponge Action were actively done with creating huge impact to prevent climate change and to protect water/ empower women.



9) Peace Caravans for Asian Collaboration Community were organized in Japan, 2013 Nov. with NICE (host) and 12 leaders of 8 NGOs in 6 countries and greatly promoted i.v.s. to people.



10) Asian Voluntary Service (AVS) as the Long/ Mid. Term Workcamps was historically created at the Asian LTV Summit in 2013 and will start from 2014 Apr. as the pioneering initiative of i.v.s. NGOs.

The projects organized by the member NGOs of NVDA (that should occupy a quite majority part of the whole movement in Asia) have been increased years by years (with a bit up-down).

The total number for 2 years in **2012-13 was 2,659 which is 22% increase** from 2010-11..

Especially, LMTV (LTV and MTV) got quite rapid increase in a long term since the mid. 2000s (LMTV occupied 13% in 2006 and 33% in 2013).

[Brief History of i.v.s. in Asia]

The first i.v.s. project in Asia was started in **India in 1930s by SCI** (Service Civil International) that has also created branches in several countries in Asia in 1950s-60s already within their network.

There are a few other international NGOs such as ICYE (International Cultural Youth Exchange) and FIWC (Friends International Work Camp) which started the activities in Asia from 1950s.

Besides those ones that exchange volunteers within their own networks, there has been **very few countries and i.v.s. NGOs** that organizes and exchange volunteers in the wider area till 1980s.

However, the number of i.v.s. NGOs in Asia and their projects have been **rapidly increased since 1990s** due to the growing needs of i.v.s. in the societies both for communities and volunteers and development of NGOs and social entrepreneurship.

So, 11 of those NGOs created NVDA in 1997 for 1) creating i.v.s. in "new" countries, 2) developing the qualities and quantities of i.v.s. in "existing countries" and 3) creating common actions on environmental and social themes. It is widely recognized that **NVDA has been acting a very important role** for development of i.v.s. in Asia.

As for the governmental sector, JOCV (Japan Overseas Cooperation Volunteers) sends LTVs for 2 years to less expensive (so called "developing") countries since 1965, stimulated by creation of Peace Corps in the USA in 1961. UNV (United National Volunteers) was created under the UNDP in 1971, KOICA (Korea International Cooperation Agency) was started in 1991 and a few more countries are starting similar scheme recently.

Themes the projects focus are **quite balanced** in total while **education and environment are two major** themes. Environmental occupies nearly half in VSTV and no cultural ones are done for LTV.

- * Planting trees, maintenance of forests
- * Creating eco-villages, Organic farming

- * Construction of the school, toilets, clinics

- * Protecting & renovating heritages of temples
- * Organizing festivals against discrimination
- * Archaeology/ Drawing arts on the wall

<u>Educational</u>

- * Teaching English in the school
- * Playing with the kids in summer camps
- * Environmental/ cultural/ social educational

<u>Social</u>

- * Gardening, playing with the kids in the orphanage
- * maintaining home for mentally challenged, elders
- * Empowering refugees, indigenous, HIV positive

<u>Others</u>

- * Peace campaign/ interviews to the war victims
- * Research/ Advocacy to the governments
- * Helping office work of NGOs

* The project costs a lot and Fee becomes too high.

- * Not a few are interested more in going abroad.
- * I.v.s. is still not widely/ well recognized.

But these factors are not new and outgoing number is not increased, so cannot explain flow.

9,273 Outgoing volunteers joined the projects that is almost same (**2% less**) as **2010-11**.

The big majority of outgoing volunteers have been from expensive (so called "developed") countries/ area such as Korea, Japan, Taiwan and Hong Kong, but recently, the number from less expensive countries, especially **South East Asia**, **has been increased quite much** within South Asia, to East Asia and Europe, possibly due to;

- * Economic development (less price differences)
- * Cheaper flights by LCC (Low Cost Companies)
- * Increasing interest to go abroad and i.v.s.
- * Big efforts of NGOs to promote (some of them make quota to exempt the fee from each other).

In 2012-13, **609,309 days were spent by the volunteers** that is **2% less than 2010-11**. This can be equivalent to 2,603 full time workers (working for 4.5 days in a week) as the volume.

But it will be much more if we include **hundreds thousands of local people** working/ living/ exchanging together with the volunteers.

And for sure, values and benefits of i.v.s. are **far more than this** figure since it creates various types of huge impact many of which are invisible.

It is a pity that **Asia hosts almost no volunteers from Africa** while it send quite many there. There are some difficult situations (visa, finance, etc.), but hopefully, exchange will be more balanced near future.



< Sex of volunteers >

As we all global trend in a long term, (official) **female vols. occupy 2/3** of the total number.

This has been discussed for many times and possibly due to (not sure and not apply always);

- * Female is more curious and active to new things.
- * Female prefers more collective life than male.
- * Female is more free to do from outside of power.
- * NGO organizers of male are so attractive (!?!) How do you think??



< Occupation of vols. >

This is another global trend in a long term, **students occupy 2/3** of the total number and especially, over 80% of outgoing vols.

Especially in Asia, it is quite difficult for many workers to get long holidays in many countries while many European workers can take some weeks holidays even successively.

On the other hand, as the number of people who started i.v.s. in their student days is reaching quite many, there could be more potential to target them by having easier access such as organizing shorter term projects, keep sending news, etc.

The following information has been taken from the Annual Reports from the member NGOs, "What were remarkable external situations/ changes in your country related to i.v.s.?

< Bangladesh >

People love to share with different cultures and both of foreigners and local love to practice English. (BWCA, 2013)

< Cambodia >

Government promotes voluntary service by recruiting university students to participate in land license to people. It helps to make the youth feel the important of volunteer work. (CYA, 2012)

National Government and many local and international NGOs start working on voluntary service and make it recognize by the private sector and other stage holders. (CYA, 2013)

< India >

New youth policy is developed and implemented in both regional and national level. I.v.s. is still not highly recognized in India while the number of organizations promoting local volunteering activities are increased. (FSL, 2012)

There was change in Indian visa regulations that all volunteers arriving to India (short or long term) must come with an "Employment with NGO Visa". (FSL and RUCHI, 2013)

Visa beyond 6 months stay is treated as Employment Visa which needs more paper work and delays. (RUCHI, 2012)

Delhi and a few states will have elections in 2013 Dec. and change of power is expected. There is uncertainty over the policies of new government if elected to power. (RUCHI, 2013)

In India there are still lot of work need to be done by i.v.s. (SMILE, 2013)

< Indonesia >

Formal education based institutions to cover all expenses of hosting LMTVs enables IIWC to host international vols. from more countries such as Eastern Europe & Russia (IIWC, 2012)

Trend of going abroad for young people increased significantly. (IIWC, 2013)

< Japan >

 "Dangerous" image of Japan was removed much (so, number of incoming vols. recovered!).

- 2. Democrat party which was quite friendly to NGOs/ NPOs lost in the national election.
- 3. More LCC flies also inside Japan that helps vols. to travel with lower price. (NICE, 2012)

1. Gap year is promoted by various stakeholders and universities got big fund from Government.

2. Voluntourism is rapidly developed and competition with NGOs is getting harder.

3. Visitors from South East Asia are rapidly increasing that also effects i.v.s. (NICE, 2013)

< Korea >

There are more CSR with i.v.s. (IWO, 2012) More Korean are interested in i.v.s. and the number of youth projects supported by the government and corporations is increased. As these projects normally have financial benefits, many Korean youth apply for them. (IW, 2013)

No significant situations or changes in Korea. However, there was a presidential election in the end of 2012, and with the new administration in place, budget constraints are expected in various sectors within the nation. (KNCU, 2012)

< Macau >

Our government is now drafting the New Youth Policy which shall involve and influence the area of voluntary service. (MNCYA, 2012)

As we lead a good start, there are more and more NGOs in Macau trying to start voluntary projects with other NGOs or networks outside Macau. (MNCYA, 2013)

< Mongolia >

All university students receive grant from government, so many of them wish to study more and also to help to others. Before they were busier to work for money. (MCE, 2012)

Still many Mongolians and locals treat the vols. as tourist. Too much welcomed and also they think, they are rich. More and more companies talk about their social duty (CSR) and are trying to help for others. (MCE, 2013)

< Myanmar >

The main remarkable change is permission for foreigners to stay in local community in workcamp area. Myanmar policy has restricting on stay permit to visitors and it is still active, so all the workcamp areas have the first experience of hosting International volunteer with a group in the certain length of time. (COM, 2013)

< Nepal >

Very big change through the constitutional election and the democratic party will going to make new government soon, with which we will have more chance to invite vols. (FFN, 2013)

No change. We have been discussing about volunteering visa. (VIN, 2013)

< Philippines >

Some major universities conducted volunteer fairs/ volunteer organization fairs for the development sectors which enable us to reach more people in the academe. (YSDA, 2012)

< Singapore >

Promotion of social enterprise. (GVC, 2013)

< Sri Lanka >

Many people need to know about workcamps and what this foreign people do here to understand the value of volunteerism and cooperation. Most youths understood the value of education. Some aged people talking about the political and economic situation of other countries. (GV4GF, 2012)

During the conflict period, NGO did huge role on a development sector to paying every participator and we have to change this mentality little by little. Local economic situation is pushing people toward "work for cash" instead of "volunteerism". (GV4GF, 2013)

< Taiwan >

Teenager is requested to have S-L experience at 30 hours before they go for University. (VYA, 2012)

New umbrella network "Taiwan Aid" was registered by more than 30 NGOs in Taiwan. VYA Taiwan is one of the funder NGOs. (VYA, 2013)

< Thailand >

Normally, voluntary projects in Thailand are for usual actions. But this year, i.v.s. got more attention from other volunteer networking. They want to cooperate with IVS and doing peace or voluntary projects together. This is good signal of IVS to grow in Thailand. (VSA, 2013)

< Vietnam >

 Outstanding volunteer reward will be applied as the annual reward for the most outstanding organization and individual in voluntary service.
 Law on Volunteer is being proposed to the Government. (SJV, 2012)

National year of volunteering in Vietnam was announced and celebrated official by our Prime Minister as a National program which is a big remark for recognition of volunteers' contribution for development of our country. It also marked our first step to celebrate our 10th anniversary in 2014. (SJV, 2012)

- 1) Local authorities in some provinces like Hai Duong, Phu Tho have created favourable conditions for VPV to implement the i.v.s. programs. For instance, the two German LTVs in Phu Tho got one year visa thanks to the critical support of the local department of foreign affairs. Also, the department of education and training in Hai Duong province has allowed VPV to organize its activities in several different communes and districts.
- 2) There were more organizations working in this field while there were less international volunteers coming to Vietnam. (?) (VPV, 2013)

2-3) Projects and Impact

There are various ways to define and categorize the impact of international voluntary service projects that is also researched by some special international projects including the one introduced in the Chapter 3-7.

This is one way made by NVDA President.



- * Impact on each level: Personal/ Local/ National/ Regional/ Global
- * Impact on each stakeholders: Volunteers/ Local hosts/ Local people/ Governments/ Schools, etc.



Now, we introduce some examples collected from the member NGOs through their Annual Reports for 2013.

< Bangladesh - BWCA >

- * **Project**: LEAD Programme 2012-13
- * Dates: 2012/12/21-13/01/05, 2013/06/08-21
- * Story: Community peoples are used to get benefit through tree plantation, health awareness and interaction between foreigners and locals during work together. Both of them (foreigners and locals) get to know each other's culture and many other things through communicates among them. They also got benefits indirectly through developing the infrastructures of VTC by the token participation of volunteer's physical labor in ongoing construction work. Because VTC has

been establishing for the promotion of local people as a whole.



< Cambodia - CYA >

- * Project: Drama and Art camp
- * Dates: 2013/08/11-24
- * Story: This workcamp involved around 20 local students in the activities and many local people and authorities. Afterwards, the high school teachers & principal recognized our wonderful job for the students in community and principal came to us and ask for a bigger cooperation.



< Hong Kong - VT >

- * **Project**: Long Valley Rice Harvest
- * Dates: 2013 Jul. 22- Aug. 04
- * **Story**: The workcamp was held in a rainy and typhoon stricken season. With the help from volunteers, most of the eco-paddy rice was spared from turning rotten, thanks to timely harvesting. The paddy rice is one source of support to a local environmental organization, Conservancy Association.



- * Project: Ping Che Village Weekend Workcamp
- * Dates: 2013 Nov. 15-17
- * Story: The village is under controversy relating to urban development. Rural villages in Hong Kong have its rich folk cultures and history. However, the number and scale of rural villages decreases following increasing urbanisation. Hong Kong young volunteers took part in this workcamp and seized the chance to understand this neglected part of their city, besides all the skyscrapers. It gave them a chance to think about the relationship between land and human.



< India 1 - FSL >

* **Project**: Samsung Employee Volunteer Program

- * Dates: 2013 Nov. 09-30
- * **Story**: What could we accomplish if we joined together with people from a different part of the world for a common purpose, put behind them the muscle and strength of a large multinational company and then supported them with 13 years of experience and knowledge of our country? One answer is a 'Smart Class'.

The irony remains that while India is considered to be the IT hub of the world, many rural schools in India, where close to 70% of the population lives, still do not have adequate computer labs or teach computer literacy skills as part of their curriculum. We aimed to address this challenge by bringing together various stakeholders to build a computer lab or 'Smart Class' for children in a village in the southern Indian state of Tamil Nadu.

54 vols. worked over 2 weeks to set up the 'Smart Class' in Keeranallur Government High School located in Kancheepuram. They painted the building, complete the flooring, set up the furniture and lend a technical hand to finish up on the electrical work. The lab was then furnished with 20 Samsung laptops to help provide education and computer literacy to nearly 300 children at the school, attending from 6th to 10th Standard aged from 11 to 16.

The vols. also worked to ensure sustainability of the initiative by training close

to 13 teachers of the school in basic computer literacy skills, enabling them with the capacity to pass on the knowledge to children. They also developed a curriculum for the purpose.

The construction and setting up of the 'Smart Class' took place in Nov. 9th to 22nd, as a part of the Samsung Electronics Employee Volunteer Program, a Corporate Social Responsibility (CSR) initiative of Samsung Electronics Pvt. Ltd., South Korea.



- * Project: Keep Lal Bagh Garden Clean
- * Dates: 2013 Aug. 15
- * Story: FSL-India Bangalore Chapter's more than 2-month long 'Keep Lalbagh Clean' campaign culminated in a clean-up initiative. Close to 100 participants came together at Lalbagh Botanical Garden, with one singular objective: 'bring about sustained change in the mentality of Lalbagh visitors to ensure a clean environment within the park.'

Within a period of **5 hours**, more than **1000 litres of trash** was collected, with an estimated **25,000 visitors viewing the campaign's message**. It took place during Lalbagh's famed annual Flower Festival, which received close to 450,000 visitors in Aug. 7th-15th. The mood of the participants was enthusiastic and positive. Many commended the initiative and expressed a wish to participate further in such activities.

It is hoped that FSL-India undertakes another initiative to Keep Lalbagh Clean, in the upcoming flower show at the beginning of 2014.



< India 2 - RUCHI >
* Project: Water Development Project
* Dates: 2013 Jul. 12-26

* Story: By a bilateral project, an irrigation tank using highly skilled technique of ferro-cement was constructed in a water scarce village of mountain area. The tank was linked with roof for rain water collection. Due to this irrigation facility increased and about 2 hec of land was watered. During the last season, 6 farmers got extra crop of vegetable and increased their income by approx. 100 USD per family. They are very happy to own the water storage tank.



* Project: Sustainable Development & Health

- * Dates: 2013 Feb. 04-Mar. 07
- * **Story**: A Finnish MTV was involved with a Health project and conducted about 200 Rapid Test for T.B. diagnosis in the slum areas. She was able to study their living conditions very closely which opened her eyes on the development concerns at the grass roots level. Afterwards, she was very happy to learn some of diagnostic skills and gain practical grass root experience. She returned with great satisfaction.



< India 3 - SMILE >

- * **Project**: Street Children Project
- * Dates: Ongoing
- * **Story**: We had many successful events and impact on the poor street communities . We could involve parents in the education sector. New self help group created on our support. Training programme started for the children and parents . We could extend our activities at four. Different places around the city.

< Indonesia 1 - DJV >

- * **Project**: Patrimonito
- * Dates: 2013 Aug. 24-Sep. 06
- * **Story**: We involve the local communities especially youths and children in our project in reconstruction the Sewu Temple. The youths have more understanding about the importance to preserve the world heritage site in their area.
- * **Project**: Elephant Project
- * Dates: 2013 Dec. 07-16
- * **Story**: The vols. have more knowledge in preserving and protecting elephant as they were involved in the daily activities of *mahout* (the person who in charge for the elephants).

< Indonesia 2 - IIWC >

- * Project: WHV Borobudur Camp 2013
- * Dates: 2013 Jan. and Sep.
- * Story: Students in the Young Guardian Club finally can organize themselves. The YGC Borobudur Leader in 2012 Aug.-2013 Aug. named Miftah from local high school was selected by INCU as a national representative of youth leader for WH International youth forum of UNESCO in Cambodia. The next leader of YGC become speaker in the YGC training in another WH site of Ujung Kulon and inspire 15 students to become the 1st YGC Ujung Kulon members.
- * Project: WHV LTV Young Guardian in Action
- * Dates: 2013
- * **Story**: Vols. were accepted in some scholarships from Indonesian government for studying culture and Bahasa Indonesia.

< Japan - NICE >

- * **Project**: Showamura
- * Dates: STV (5 times in 2013) and LMTV
- * **Story**: "Young vols. come to our villages every month. Many abandon fields have been revived and the community has been activated and empowered through the continuous work and exchange with them. We had almost lost, but got hope again for future of the village thanks to them", the Director of the local host NGO said.



- * Project: Katsuyama
- * Dates: 2013 Jul. 22-28
- * **Story**: In this first international family workcamp in Asia, 12 kids from 4 countries got amazingly closer so quickly (slept together on the same mats from the first night)!

The Mexican father said "we learned a lot from the eco-friendly traditional culture and want to have a family workcamp also in my country. Some kids cried in the end.



< Korea 1 - IWO >

- * **Project**: Global talk in nature
- * Dates: 2013 Aug. 10-24
- * **Story**: International vols. run summer camp for local youth. Students had opportunities to join various activities with volunteers. After the Workcamp, local youth changed their attitude like taking part in the afterschool programs more actively, studying English hard.



- * Project: Global Village
- * Dates: 2013 Jul. 18-30
- * **Story**: A participant who joined IWO's workcamp as a camp leader, returned to IWO as local partner. He is a teacher of middle school which was one of the workcamp hosts in 2013. He learned intercultural diversities and global citizenship through his Workcamp so that it made him to host workcamp in his school.



< Korea 2 - KNCU >

- * Project: Jeju
- * Dates: 2013 Aug. 08-22
- * **Story**: The vols. made a trekking course with local residents and tourists. It provided to be an arena for everyone to get together to be aware of the UNESCO natural heritage and the potential of conserving heritages.



- * Project: Muan
- * Dates: 2013 Aug. 08-22
- * **Story**: The vols. created a kiosk where the local farmers could sell their produce. Due to the lack of market and facilities, the farmers had a hard time selling them and through the kiosk, it contributed to the selling of local food to tourists and residents.



< Macau - MNCYA >

- * **Project**: The Feast of Na Tcha and its Parade
- * Dates: 2013 Jun. 17-26
- * **Story**: This is the first time we have non-local people to join and help with the Na Tcha Feast Parade, one of the most characteristic feasts. As a very local religious event, it did not get any attention outside Macau, or even to the new local generation. The workcamp has brought this traditional event and the story behind to both foreigners and the local youth. It helps to promote Macau as the world cultural heritage.

For many vols., it was the first time to visit Macau. Beforehand, they have just heard about the gambling industry and not noticed the very unique culture mixed with East and West here. They got a good chance to join a very local religious event and learnt more about now and the past of Macau. Under a rapid economic change and modernization, they all noticed the importance of preserving the traditional culture and value also in their own countries.



< Mongolia - MCE >

- * Project: School-3
- * Dates: 2013 Oct. 04-17
- * **Story**: After the workcamp, school kids study English harder by report of teacher.



- * **Project**: Harvest-1
- * Dates: 2013 Sep. 09-22
- * **Story**: Some vols. didn't want to leave the workcamp because they wish to help more!



< Myanmar - COM >

- * **Project**: Pyin Oo Lwin Workcamp
- * Dates: 2013 Feb. 28-Mar. 11
- * Story: The technician from US and the training alumni from environment protection training demonstrate the importance of saving world and how to build simple earthen house with local product in their workshop. Within two weeks, vols. finished building rest house with local product such as wood, hacks and mud. Vols. also could give awareness to the local community for environmental protection and enthusiasm of committed to work. The achievement creates the local community to appreciate the inspiration of voluntary work and recognized the effort and team spirit of international and local volunteers.



- * Project: Ywargan Workcamp
- * Dates: 2013 Oct. 18-31
- * **Story**: The workcamp was organized in Lantern festival to help the farm but the local community leaders requested vols. to join their ceremony. The proposal was to dance Danu (local race) way in front of over 600 audiences. Vols. had only one day to practice, but achieved to overcome the event and did well in the show. They learnt rich culture of local area and nation.



< Nepal 1 - FFN >

- * **Project**: Orphans home
- * Dates: 2013

* **Story**: Vols. from Europe were very happy and like to stay with children there. This orphanage was built by us and local people and vols. help from 2009-2013 until now as a 5 years plan.



< Nepal 2 - VIN >

- * **Project**: School health talk on hygiene and sanitation/Jitpurphedi Gardening & Painting
- * Dates: 2013 Jul. 04-17
- * **Story**: Many activities were conducted to bring development in schools of the community. 14 international and some local vols. were divided into 3 groups in order to draw attention of all the stakeholders; especially the school children to improve their personal hygiene and sanitation. It was divided into 2 sections;

awareness sessions on personal health and hygiene and garbage collection. Achievements;

- * 9 schools children were benefited
- * 1200 students benefited from health session conducted in 9 schools. They learnt and practiced the ways to brush their teeth and wash their hands.
- * 653 children received tooth brush.
- * The school surroundings and the toilets of 9 schools were cleaned

"I think it is one of the summer ever. As a nursing student, I always dreamed to do this kind of project. All campers were so sweet and it was so special experience for me. I am really appreciated to VIN which gave me a best summer camp. I think I am gonna miss all of members & VIN staffs. Thank you." (Korean vol.)



< Philippines - YSDA >

(Impact on communities)

- * **Project**: Coastal Eco-system Restoration
- * Dates: 2013 Jun.
- * Story: Vols. educated children on toxic waste and health, then led the children in conducting corals and coast rehabilitation. Because of the great impact, it was set as YSDA's flagship project for qualifying in the Ten Accomplished Youth Organization of the Philippines and made the organization advance to the regional finals.





- * **Project**: Food for Thought
- * Dates: 2013 Mar. and Jul.
- * Story: Vols. could increase their awareness on health and education issues as they were exposed to different social environment. They appreciated what they have and learned how to be compassionate with others.



< Sri Lanka – GV4GF > (Impact on communities)

- * Project: Renovation of a clay house
- * Dates: 2013 Oct. 06-19
- * Story: This house was made by only clay and not even plastered. There are 4 family members incl. 2 children. Father was addicted to alcohol and most of his wage spent for illicit liquor. Only mother's wage contributed to house management and studies of the kids. So, the vols. plastered this house to protect from rain water, then applied a first coat of white lime.



- * **Project**: Cleaning the village lake
- * Dates: 2013 Sep. 14-27
- * **Story**: This was organized for cleaning the lake. Over 50 local farmers and their family members joined. Vols. joined cultural event offering to regional god, played with local youth and joined children activity and to plant trees. This workcamp gave different kind of experiences about, local culture, youths and community.



< Taiwan - VYA >

- * Project: Xi-lou project
- * Dates: 2013

* **Story**: We initiated the project in 2010 and now local host was recognized as the specialist of repairing the historic house and Mosaics public art. The project was highly recommended by community and local government as well.



* **Story**: After we started i.v.s. in Taiwan in 2002, now IVS movement is a new trend and life style among young generation. Society puts more effort to encourage young generation getting involved in public affairs. Many people are looking forward to contribute the global society.



< Thailand 1 - DALAA >

* **Project**: DALAA-NICE 2013-01

- * Dates: 2013 Sep. 09-22 (Bilateral camp)
- * **Story**: This was taken place in one of our longterm project sites, Roy Wan Pan Pba Alternative School. Vols. contributed to the local community so meaningfully for activities they organized for the village kids in a non-formal educational way, work on non-chemical vegetable gardening areas, host-family program that they were welcomed to stay with villagers for some nights.

In a rural Thai lifestyle, they and villagers share each other about what they know. Vols. in deed brought happiness to the village even though it's just a short time and it ended in tears.



- * **Project**: 1301MLTV Baan Kok Riang
- * Dates: 2013 all year (MLTV program)
- * **Story**: Like every international vol.'s first time living in a totally different lifestyle and culture, they need some time for a while to adapt into

new environment (especially European vols). They cannot get adapted to everything in just a week. After the first month's arrival, they become acquainted with the Thai lifestyle, respect our culture, be patient to listen and understand. Easy-going character has shown and eventually we are informed they have improved themselves a lot, their stay is too short to learn everything. That's what we really are proud of. However, that's the majority we can conclude from our former MLTV volunteers.



< Thailand 2 - VSA >

- * Project: MLTV1303 Culture/The Institute Southern Thai Study Project
- * Dates: 2013 Aug. 01-31
- * **Story**: The staffs of the institute were willing to preparing to be welcome ASEAN Community on 2015 and one of the preparing is to be ready for the communication. English is still difficult for Thai. The mid. term vol. staying for 2 months helped the work in folklore museum. This was a chance for the institute staffs to use English since the welcome gate (security) to boards.

Before everyone was shy to communicate with foreigners, but after 2 months of motivated vols. from Italy, most of staffs felt English is not difficult as they thought. They don't run away from foreigners anymore and are enjoying welcome international vol. as their relative.



- * **Project**: From Thai member to VSA staff * **Dates**: 2013
- * **Story**: Gear is Thai vol. who was willing to learn English. Before his English was not very good and his personality was very shy. But after he joined VSA projects, training to be a camp leader.

Now gear become VSA staff as a part time camp leader. And he was selected as a representative of his university to make a speech about the collaboration of Thai-Indonesia and Malaysia. This was unexpected for his parent and VSA. He is the one Thai vols. are attempting as a model.



< Vietnam 1 - SJV >

- * Project:
- * Dates: 2013 Jul. 02-25
- * Story: We have finished a workcamp for building 2 houses, repairing Xuan Lam kindergarten and Xuan Lam primary school, donating 42 sets of chairs, tables, medical equipment, 16 cows and 160 mosquito nets for poor families at Song Cau, Phu Yen. With the cows we provided, the community could start a new income method for come over the poverty that they have suffered for many years. Many people were also got medical treatment from the equipment that our workcamps gave them.
- * **Project**: Dennis group
- * Dates: 2013
- * **Story**: There were 30 vols. from 3 vocational training schools for youth with fewer opportunities in Denmark who organized workshops, festivals together with disabled and disadvantaged youth at Hoa Sua school, the counterpart training school in Hanoi, Vietnam.

Its aim is to answer the question "How to live a good life" which made all volunteers realised that it is possible to make other people happy, confident and feel meaningful to the life they want doesn't matter what background they come from and how difficult their current life are. In the festivals, there were 12 Australian disadvantaged youth also joined in and they were very glad to share their own experience and recognized how much fortune they have. They all admitted that they learnt and gained so much by giving, sharing their chances to others.

< Vietnam 2 - VPV >

- * **Project**: Summer community English and French classes
- * Dates: 2013 Jun. 15-Aug. 15
- * **Story**: This is a regular project that VPV organizes every summer in Hanoi. By offering FREE classes for local students and children, the project has open up the opportunity for local students and children, especially those from disadvantaged backgrounds, to interact with international volunteers, and thus improving their English/French communication skills. This is also a great chance for the locals to learn more about other cultures and enhance their intercultural understanding.



- * **Project**: World Heritage Workcamp at Thang Long Citadel in Hanoi
- * Dates: 2013 Sep. 09-21
- * Story: This was an educational project that applied a number of non-formal education methods. Joining this project, volunteers, both national and international, got the chance to acquire deeper knowledge about this World Heritage site in Hanoi and improve their understanding and skills in non-formal education. They got to run school workshops, present the topic to many people, organize interactive game shows and related events. This project also brought foreign volunteers the opportunity to interact with a wide range of local people, which enabled them to get an insight into the local life and culture.



3) Projects and Actions of NVDA

3-1) Regular Networking Projects

2-1-1: The 9th TNW with the 8th GA

It was **wonderfully and successfully organized** by RUCHI (host), all the participating NGOs and their leaders, local people and NVDA!

[What is TNW & GA?]

TNW (Training & Networking Workcamp) with GA (General Assembly) of NVDA gathers top leaders from i.v.s. NGOs in Asia and the world to; 1) **Improve and develop** projects & management 2) Help **starting i.v.s. projects** in "new countries" 3) Strengthen **common actions & partnership**

It is very rare, **unique way of GA in a workcamp style** in the local project of the host NGOs, where they work, discuss and have a fun together in a simple and enjoyable collective life.

It is held **every two years** and hosted by a member NGO by turns, open to all member NGOs and some NGOs in "new countries" where there are no i.v.s. yet and from partner networks.

In the past, many youth committed suicide in this lake, so the local people broke the bank and lower the water level. But it has brought various negative effects environmentally, so we have worked to recover the nature in this project.



* It was huge work, but many mothers suddenly came and collected small woods to use for cooking, so the area has been completely cleaned up[©]



Up: Enjoying fresh avocado grown here. Down: Planted 30 seedlings of mango & coconuts. Vols. Were so happy that so many kids joined naturally and of course, they played together. In Sri Lanka, there had been inner war for a long time that was finally ended in 2009. So, we also aim to reconcile and promote solidarity among youth of different races by planting trees together and also keep maintenance afterwards!

International workcamps were originally started in 1920 by French & Germany youth to reconstruct farms destroyed by the World War I. It's been over 90 years since that, but this spirit has been succeeded also in this project.



Left: We had to take cold water shower though it was quite cold due to high altitude. Food was tasty, but spicy. Some tried to eat by hand. Some even used hands in toilets respecting a local way. There was no internet nor mobile phone line, The life was a bit hard for some vols., but they have adapted and even enjoyed in the end!

Right: Cultivating in the organic garden of Tamil family. Those people lost citizenship in 1948 (independence), but could not go back to their original place of southern India as well, so they've been living as "rootless wonderer". But since a few years ago, they have been allowed to own the pieces of lands, so they manage their life by organic gardening and also working in the tea fields/ factories (main industry here).

One ole man watched our work and gave us the fresh carrots from the garden. He's been fighting for the rights and life of the Tamil's tea factory workers since the colonial age. It was so strong and sweet, totally different from those sold in the grocery shops, as if showing his life.

What have been planted in Passara: mango, coconuts and also small, but valuable links of hearts and hope for the future. We are looking forward to seeing how they will be grown!

Popular rock band came for our farewell party and we had a very participative and funny concert with them and the villagers under so many stars.

An old man started talking "this village hasa a terrible history with Japanese army in World War II since we are in British side. Elders never forget it. But it was really good that you have come to this village this time". It may take some more time to heal injury from the war, but we'd try to create a new history even with a small step!

3-3) Improving qualities of international voluntary service NGOs

NVDA is working to improve **both qualities and quantities** of existing international voluntary service NGOs and their projects.

3-3-1 Global LMTV Meeting(GLM)

More international voluntary service NGOs are organizing projects/ exchanging volunteers of LMTV (Long/ Middle Term Voluntary service) in these years while the common working system for LMTV has not been well established yet as the short term workcamps, so we need to develop it together to improve the quality of the projects and the volunteers, but we rarely have an opportunity to meet mainly because most of participants in the meetings of different networks are in charge of short term workcamps that are main activities for many NGOs.

This is why the Asia Europe Training for Trainers on LMTV was organized in Tokyo, Japan in 2009 Feb. 11-17 by NVDA and ASEF (Asia Europe Foundation) hosted by NICE. Then, NVDA has initiated to start and develop Global LMTV Meeting with CCIVS and ALLIANCE;

* 1st GLM in Germany in 2010 Mar. 02 with 52 pax (38 NGOs in 24 countries) hosted by VJF
* 2nd GLM in Vietnam in 2011 Apr. 06-10 with 20 pax (12 NGOs in 9 countries) hosted by VPV

The Global Coordination Team consists 6 representatives from 3 network and NVDA's President (Kai) and General Secretary (Phuc) has continuously leading roles there.

Asia has quite big presence in LMTV in the world (number of projects, vols., etc.) to compare with Short Term projects that may be another reason why this is strongly initiated by NVDA.

For example, Bird from VT (Hong Kong) stayed in NICE (Japan) in 2013 Oct.-Dec. and joined various projects and helped its office work.

2-3-5: Opening Finance

It is annually collected from the members since 2010 with aiming to;

- a) Understand each management better
- b) Learn from others practice
- c) Get more reliability from vols. & partners

Some of the results are introduced in 6) Finance while the whole information is opened only among the NGOs which has submitted.

2-3-6: Camp leader training

Dharamvir (RUCHI), Vice President for Quality Improvement made initiative to collect the existing tools to train the project leaders from the member NGOs.

3-4) Developing PR of international voluntary service NGOs

3-4-1: 2nd PR Summit of i.v.s. NGOs

< Comments from the host organization (SJV) >

The first one was successfully organized in Japan, 2010 with NICE (host), Japan Foundation and 22 PR leaders of 13 NGOs in 12 countries. That may have been the first international meeting on this topic in i.v.s. movement and made many good results to share visions and know how, to make partnership and common actions.

3 years after the 1st one, 2nd PR summit was successfully organized in Jan, 2013 host by SJ Vietnam with big effort of coordination team and great contribution of participants who are PR coordinators in i.v.s organizations. There was lots of sharing by PR expert, university teachers, UNV specialists, journalists, leaders of local NGOs who had many influencing story of PR strategy, campaigns in their organizations.

The topics were discuss to increase number of volunteers, to win grant proposals, to success calling for donation and to use all IT tools for PR work efficiently, etc very attracted participants as they are the daily needs in our i.v.s organizations.

In Asian i.v.s night, many touching life stories were told by PR coordinators and NVDA leaders to show us how voluntary work contributed impact to community development and improve personal development of volunteers.

2nd PR summit was not only a good opportunity for i.v.s PR coordinators to share our best experiences and learn new knowledge but also an evidence of our good job could be recognized more widely by local community and stakeholders when they know the influencing storied from us and the reason why i.v.s organizations make all of our effort to build a better world together.

3-6) Common actions of NVDA for environment/ social improvement

One of valuable character of NVDA is its various kinds of active common actions for not technical internal matters in the network, but for social issues that can hardly seen in any other networks!

3-6-1: World Tanabata Action

- Green the land & heart to stop climate change -

a) Description:

This is a global common action to 1. Plant trees (or other actions to decrease CO2) 2. Study/ discuss on the climate change issue 3. Write "my action" on "Tanzaku" papers

Tanzaku papers are collected and exhibited in the G8 Summit, the UNESCO Conference, etc. It was started by NICE in 2008, co-organized with NVDA, CCIVS and CONCORDIA, with many NGOs & people of all over the world.

Tanabata is a Japanese old custom from the old, romantic tale and people write wishes on the Tanzaku papers and hang them on the bamboo trees in the night of 7th July every year!

<u>b) Aims:</u>

- * Decrease CO2 emission by practical actions
- * Raise awareness on climate change
- * Promote cooperation among NGOs and people

<u>c) Results</u>

* Since 2008, 27 NGOs in 21 countries reported (incl. 17 NVDA members in 15 countries).

Then, asked the people to grow for 2 years (and transplanted into the original forests)!

< SJV (Vietnam) >

- * 50 tanzaku papers were collected in 2 bilateral workcamps with NICE in 2012.
- * Benefits: Connect youth in environmental issues as well as to support the people in the Fisher Village, we got a wide network of young local people who show their interest in the project and would like to continue supporting.

< RUCHI (India) >

We planted 500 trees near the water sources and in 8 government schools, by 4 workcamps. School children were involved in planting trees.

Besides tree plantation, awareness campaign was also launched for people education. For active participation of people camps were held at various places where environmental education was given.

Benefits: Increased greenery and awareness of people on our environment. This is a campaign which must go on to increase green cover and sensitize people on climate change.

3-6-2: Asian Beautiful Cultures

Asian Beautiful Cultures (ABC) was a new action created and approved at the 8th GA in 2012.

It aims to promote protection of "infamous, valuable, in danger" cultural heritages in Asia through the photo contest on the website. However, we could not start it.

3-6-2: Eco Sponge Action (ESA)

- Protect the water & encourage the women -



(Giving sponges to women in the village of Laos)

a) Description:

Eco sponge is made of acryl with which you can wash most of dishes without washing soap by its special function (no sanitation problem!).

So, this can contribute to environment (less pollution in the rivers), health (chemical soap is not good for our body!), economy (save money to buy soap) and life (save time for rinse).

It was originally proposed by NICE in 2003 (International year of Freshwater) and have been made/ used in many workcamps, local communities, schools, etc. in the world.

From 2009, a new type of actions are done in a fair trade style with SJV and NICE where several women in the Fisher Village, a slam of Hanoi, Vietnam (more than 40 poor families live in temporary ragged boats on the Red river) make sponges that are brought back by Japanese vols. of Special ESA workcamps to be sold in the festivals, seminars, etc. for income generation.

<u>b) Aims:</u>

- * Protect the river/ lake water and your health
- * Support the life of disadvantaged women
- * Save cost to buy soap and time to wash dishes

c) Results

- * Since 2003, over 7,000 sponges were made and used by over 5,000 people of 10 countries (by IIWC Indonesia, MOVE Malaysia, SJV Vietnam, INEX Slovakia, CONC UK, UNA UK, LEG Italy, CONC France, MCE Mongolia, etc.)
- * In the mountain village of Malaysia where people flush water from daily life directly to the river, vols. promoted to use the sponges.



* Special workshop was organized in the Technical Meeting of ALLIANCE in Slovakia, 2013 Mar. and over 20 NGO leaders joined.

< Special ESA Workcamps>

8 bilateral workcamp were organized with SJV and NICE in 2012-13.

* Main activities in 2012-13:

- Carry acryl from Japan, teach them a new technique, give back money of selling Acrylic sponges from the last workcamp.
- Do useful activities at Fisher Village such as making water filters, organizing activities with kids, cultural exchange with the people, etc.
- Promote ESA project by organizing workshops in different universities.
- Bring the sponges back to Japan and sell them in various festivals, seminars, shops, etc.

* Achievement and impact in 2012-13:

- + 918 sponges were made and sold in Japan that generated 275,700 yen (about 2,750 US\$)!
- + 179,600 yen (about 1,800 US\$) was directly supported to the women.

3-7) Impact and recognition

3-7-1: CCIVS's IMPACT project

Summary report of NVDA Impact research By Klaus DING from VYA Taiwan

Since NVDA GA meeting in India in 2012, the impact working group raised the idea to initiate an impact research project which could be involved 5 countries from Asia and another 5 from Europe. During the TM in 2012, on behalf of NVDA, the EC team presented the idea during the global meeting with CCIVS board member.

In the same year on April 20, 2012, CCIVS delivered the call for partner for impact3.2 research project. And the involved team was confirmed in the end of year. There were 17 NGOs engaged in this project which were Alliance, SCI, Peaceworks Sweden, SJ Franc, Concordia France, ESTYES Estonia, University of Salzburg University Austria, NVDA, IWO Korea, NICE Japan, SJ Vietnam, IIWC Indonesia, Dejavato Indonesia, VYA Taiwan, CSETC, UKM University Malaysia and CCIVS as well.

The first task force team(TFT) meeting was held in France from 24-28 Jan 2013 after NVDA AM in Vietnam. On behalf of NVDA, Klaus, the vice president of NVDA, and Phuc, the General Secretary, were involved in the TFT team of CCIVS impact 3.2 project and in Jun 2013, the training seminar for impact research was held in Paris, France again. After training seminar, 20 researchers joined the workcamp both in Asia and Europe in July and August 2013 to start the IVS research with the IVS impact measure tools which present by University of Salzburg University Austria in working together with UKM University Malaysia and CCIVS.

Two regional seminars both in France and Vietnam were followed in September after field research to review the first result of impact research. After that a final conference was held in China from 4-10 December 2013 to present the final result of IVS country impact research and decided the follow up steps after post impact3.2 project in 2014 to 2015.

3-7-2: Other efforts and achievement

The Global LMTV Meeting (GLM. see 3-3-1) worked hard to make the common, simple tool to measure the impact for personal development of volunteers. It was completed in the 4th GLM in Slovakia, 2013 and should be widely promoted to use by i.v.s. NGOs all over the world!

3-8) Asian Voluntary Service

The project scheme was made by the discussion and agreement in the Asian LTV Summit in 2013 Nov. 12-17 in Fukuoka, Japan where 22 leaders from 15 NGO in 13 countries gathered. As of 2014 Jan., 20 projects 10 member NGOs in 7 countries are registered.

1. Background

International Long and Middle Term Voluntary Service (LMTV) has been rapidly developed in Asia with creating unique impact to improve the situations of the environment, culture, development and so on, to activate the local communities and to promote intercultural understanding and friendship naturally, widely and deeply among the volunteers (mostly youth) and local people. It is also distinguished as one of powerful tools to grow up "global human resources" expected in many of universities, companies and governments.

On the other hand, the projects are <u>not promoted yet widely enough</u> compared with the potential needs in the societies due to lack of cross sectional collaboration, recognition in the societies and capacities of NGOs. In Europe, an exchange scheme of Long Term Volunteers named EVS (European Voluntary Service) has been actively organized since 1996 by collaboration between European Commission and NGOs in each country. As there is no such a wide inter-governmental agency in the whole Asia, <u>NGOs have even a bigger role and mission to lead creation of AVS (Asian Voluntary Service</u>) that could bring huge benefits for the betterment of the societies as well as stronger collaboration, promotion and quality improvement of international voluntary service NGOs by having common, standardized scheme.

2. Aims and expected impact



By these outcomes, we aim to create <u>a sustainable</u>, fair and peaceful world where <u>various types</u> <u>of ecologies/ cultures/ personalities/ communities can harmoniously co-exist and be glittered with</u> <u>their own characters</u> beyond limitation of the present modern civilizations which have caused too much expansion/ competition and huge destruction of nature, traditions and human relationship.

4. Financial regulation

- * Travel cost should be paid by the volunteers themselves unless there is any special fund.
- * Volunteers may also be required to pay the **participation fee (maximum**: 300 Euro per month) and the sending fee (**maximum**: 600 Euro). There can be **different rates** for less expensive countries/ less income NGOs by the regulations of the hosting side.
- * NVDA may create a **Solidarity Fund** to support travel cost of the volunteers from less expensive countries which may consist of the members contribution (certain rate of inscription fee) and donation.
- * NVDA will keep trying to find external fund.

was done in Antwerp with 13 leaders from 7 networks (ALLIANCE, CCIVS, EFIL, ICYE, NVDA, SCI, WAVAN) and completed the common statistics drafted by President (Kai) and shared many actions.

The main part is bilateral talk with partner NGOs that is beneficial to create/ develop partnership! There is usually also the meeting between 2 ECs of NVDA and ALLIANCE where ideas for cooperation is exchanged.

In the workshop, they designed a new scheme of students volunteering exchange. Ismi (IIWC) was also invited as a participant and built good partnership with the university in Brunei.

- Events organizing:

During my secretariat term of 2 years, I took part in organizing most of NVDA events as main organizers, host, facilitators or trainers such as: 9th TNW& 8th GA in India; 10th TNW& 9th GA in Thailand, Annual meeting in Vietnam, bi-monthly EC Skype meetings and 2 physical EC meeting each year and well as collecting NVDA members for a sharing session during Alliance TM every year; Global LMTV Meetings in India and Slovakia, Asian LTV Summit in Japan, 2nd PR summit in Vietnam

- Project coordinating:

During 2 years, I coordinated 19 groups of 197 volunteers from HKIEd sent to NVDA members as hosting organizations. There are 4 regular ESA workcamps each year co-organised by NICE & SJ Vietnam for promotion of NVDA common actions. A Special Group Workcamps for Networking Ex. B) What I did else for NVDA

During 9 months since Jan, 2013 to Sept, 2013, NVDA didn't have any office manager; I and NVDA president already fulfilled all work of secretariat efficiently. By Sept, 2013, together with Klaus, on behalf of NVDA, I joined task force team of Impact project for connecting voluntary organizations with academic sectors (CCIVS) by hosting regional meeting in Vietnam and facilitating final conference in Dec, 2013 in China.

The website of NVDA was hacked in the middle of 2012 and Klaus has made temporary solution, but due to this problem, only old data was present. Since the design and structure need to be reformed so far and more contents should be updated, in 2013 Oct., the website of NVDA was recovered with new address <u>www.nvda.asia</u> and new design.

For Newsletter, the first one in 2012-13 was published in 2012 Sep. by the secretariat. In 2013, 3 Newsletters were launched since summer.

The communication among members was actively improved and the number of email address from members of NVDA mailing list was also increased. New NVDA placement mailing list of NVDA was also launched since 2013.

5-7) Structure of Member NGOs

Though it is just a part of structure for NGOs (besides, EC, members, teams, partners, etc.), we introduce the results from the statistics research.

The number of full time/ paid staff was dramatically increased in 2013.

6-1) Financial Report of NVDA for 2012-13

Surplus of 2012-13 was dramatically decreased from past years mainly due to decrease of sending individual volunteers (contract partners in Hong Kong and Singapore have become members of NVDA and did not send them through NVDA that is happy achievement for NVDA...!). The balance was managed also due to lack of secretariat for a half period and President and General Secretary had to work for administration voluntarily, that cannot be done again for next period, so we need to find new income!

The new Indian Visa regulation requires all volunteers to India (short or long term) must arrive on an "Employment with NGO Visa". On one hand, it is good to see that the Indian Visa regulations clearly mentions and recognises a Visa type for volunteers. On the other hand, the Employment Visa is twice as expensive and takes more time and documents when compared to any other visa type. As a result, we are seeing a reduction in the number of short term volunteers as it is now more expensive for them to volunteer for 2 to 3 weeks in India
